Joseph Domachowski, MD, Pediatrics, a pediatric infectious disease specialist at Upstate Golisano Children's Hospital, and **Manika Suryadevara, MD**, an infectious disease fellow at Upstate, received the ASPIRE Award in Pediatric Vaccine Research in recognition of their work to provide free flu shots and pneumonia vaccinations at the Salvation Army's Christmas Bureau distribution held last December. In addition to vaccinating 460 people, from ages six months to 94 years, Upstate enrolled 1,533 children who will be studied over the next year by researchers for a study assessing new paths to reducing barriers to childhood immunizations. The award and the research were sponsored by Pfizer.

Teresa Hargrave, MD, MPH, Psychiatry and Behavioral Sciences, received a National Doctors' Day Award at Upstate University Hospital, March 30, 2012.

The training is part of the CAPPC (Child and Adolescent Psychiatry for Primary Care) initiative, administered by **David Kaye, MD**, *Psychiatry and Behavioral Health SUNY Buffalo*, funded by OMH, which is designed to serve 80% of New York state's youth under the age of 22. 30 pediatricians, family practitioners and nurse practitioners from 10 Central New York counties participated, including faculty from 4 primary care training programs. The participants rated the overall quality of this year's REACH training as 4.9 on a scale of 5 !

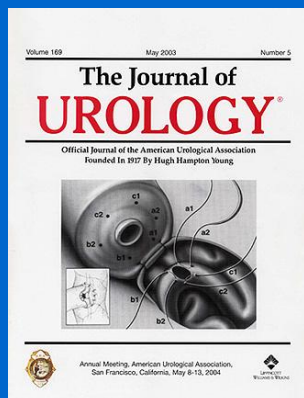

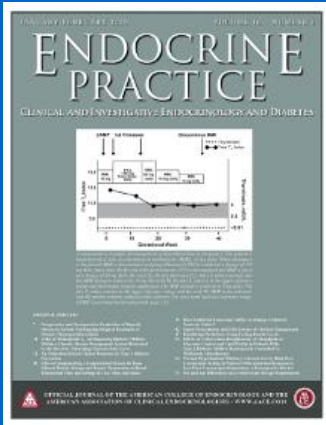

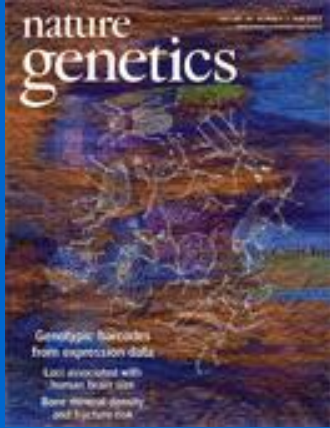
