The White Coat Ceremony was started at our College of Medicine in 1997 by Upstate President Gregory Eastwood, MD. Each year since, the White Coat Ceremony has celebrated the entrance of the newest class of aspiring physicians. The white coat is symbolic of the new responsibilities these students will undertake. More than \$2.2 million dollars was donated to the Medical Alumni Association in 2003-2004, making this the most philanthropic year in the Association's near 50-year history. For the first time, Association giving topped \$2 million, clearly ushering in a new era of support for Upstate medical students.

Since our beginnings in 1955, tuition has increased dramatically (now \$18,800) and state support for educational programs has dropped as a percentage of what it costs to educate a medical student. Your support has never been more important, and fortunately, more evident.

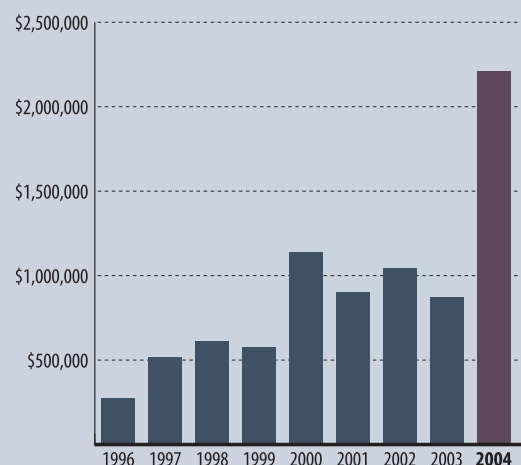

Upstate Medical University gets \$1 million gift

Donation by alumnus, who wants to remain anonymous, is biggest ever for school.

Upstate Medical University announced Thursday that it received its largest individual philanthropic gift ever—a \$1 million donation to the Medical Alumni Association from an alumnus.

"Physicians who receive their medical education here recognize how important it is to help those that follow," said Carole Novick, director of the alumni association.

The donation is from the estate of an alumnus who wished to remain anonymous, Novick said. The gift will be used to establish an endowed scholarship fund that will begin to provide aid to students in 2006. Novick expects about \$50,000 a year of interest generated from the fund to be used toward the scholarships.

Tuition for New York residents is expected to be \$18,800 for the fall semester, but the state Legislature and governor have not yet passed a budget so that figure could change. Upstate is part of the State University of New York system.

"Our tuition has been growing

at a very large rate," Novick said. "So by 2006, it will probably be over \$20,000."

The alumni association currently gives out about \$250,000 annually in scholarships to about 75 students, Novick said. The College of Medicine has more than 600 students enrolled annually.

"This extra \$50,000 will be wonderful," Novick said.

Upstate's largest previous individual gift was \$550,000. That donation came from Dr. Lloyd S. Rogers in 2000. Rogers was the first full-time faculty member in the department of surgery.

That donation was used to set

up an endowed professorship, which Dr. Patricia Numann currently holds in the surgery department.

Students who receive scholarships from the \$1 million endowment will be told the identity of the donor, who was a local practicing physician, Novick said.

"Students are so grateful for that personal connection, that someone who they didn't even know gave money to help them reach their dream of becoming a physician," Novick said. "The donor understood that."

Famous Surgeon Memorialized with Scholarship



Fiorindo Simeone, MD

John and Henrietta Simeone had long planned to create a memorial to honor the memory of John's brother, Fiorindo Simeone, MD, who died in 1990. After learning about the need for scholarships at Upstate Medical University, they decided to donate \$100,000 to establish a scholarship fund to provide financial

assistance to medical students who might be inspired by Dr. Simeone's distinguished surgical career as a prominent vascular surgeon and former chairman of the Brown University Section of Surgery.

In addition to an international reputation for his clinical research, Dr. Simeone was known as a compassionate physician and teacher, dedicated to his patients, as well as junior colleagues and students. The scholarship will be awarded to fourth-year medical students who plan to pursue a career in surgery.

The Simeones also chose the Upstate scholarship as a way to support their local community as well as "give back" for the excellent care Mrs. Simeone received as a patient at University Hospital. They have also funded an endowed scholarship at the SUNY College of Environmental Science and Forestry, where John Simeone was a professor of entomology for 35 years.
