Academic Building Nears Completion

In the spring of 2007, Upstate Medical University students will experience new state-of-the-art teaching and classroom space.

The five-story, \$11.4-million, 46,000-square-foot Rose and Jules R. Setnor, MD '35, and Stanford S. Setnor, MD '42, Academic Building will be the first new classroom space built on the SUNY Upstate campus in nearly three decades, and will provide a state-of-the-art setting for medical education, particularly the teaching of clinical skills.

The Clinical Skills Teaching Center includes 22 exam rooms equipped with closed-circuit monitoring. It is in this space that students will shape their "bedside manner" and clinical skills.

The building also boasts six new classrooms, all of which can be reconfigured or divided to facilitate small group demonstrations. Classrooms will be named for faculty members who have been recognized by students for their outstanding teaching.

They are: Robert F. Rohner, MD (Pathology); Frederick B. Parker, MD (Surgery); Elinor Spring-Mills, PhD (Cell and Developmental Biology); Maxwell M. Mozell, PhD (College of Graduate Studies); Irwin M. Weiner, MD (Pharmacology); and William J. Williams, MD (Medicine).
