The Upstate Cancer Center leadership is pleased to announce that Teresa Gentile, MD, PhD, has been named Associate Director of Clinical Research.

In this role she will be responsible for the leadership and oversight of the clinical research efforts of the Upstate Cancer Center.

Dr. Gentile is a professor of Medicine at SUNY
Upstate Medical University. She received her MD
and PhD at Upstate Medical University and also
completed her residency and medical oncology
fellowship here. She has a long history of outstanding service to the Division of Hematology Oncology,
serving as its division director of clinical research
since 2016. She was instrumental in developing the

bone marrow transplant program at Upstate, serving as director for many years while developing a regional and national reputation for excellence.

She has been active in clinical research for more than 20 years and is well known for her work in hematologic malignancies. She has been responsible for bringing many cutting-edge trials to the region and she serves as a member of the BMT CTN intergroup for multiple myeloma. Much of her clinical research work has resulted in publications and high-impact journals, including the New England Journal of Medicine.

Dr. Gentile has been instrumental in restructuring and integrating clinical research for the Upstate Cancer Center during the past four years, in collaboration with Stephen Graziano, MD, professor and division chief of Hematology Oncology. She also has been chairing the Scientific Review Committee since its inception in 2016. Interim Cancer Center Director Jeffrey Bogart, MD, stated: "Her knowledge, insight, thoughtfulness, and mentorship have largely been responsible for building a robust cancer clinical research enterprise. I am delighted that Dr. Gentile has agreed to officially take on this new role."
