All Eyes on Sepsis

Provision of high quality care for patients presenting with sepsis has become a regulatory standard of NYS DOH and CMS with both fiscal and public reporting implications. Clinically we know that early sepsis detection and early treatment make a difference. Sepsis quality data includes provider management and documentation of adherence to regulatory standards which *must* be submitted to both NYS DOH and CMS. As data have matured we have examined the relationships between compliance and outcomes:

Excess is compared to "Compliant" patient population. Here, 4.97 days longer.
