



Gregory L. Eastwood, M.D. is Interim President of the State University of New York (SUNY) Upstate Medical University, Syracuse, NY, beginning November 2013. He had been President of SUNY Upstate Medical University 1993-2006. He is SUNY University Professor and Professor of Bioethics and Humanities and Professor of Medicine. Eastwood received his M.D. from Case Western Reserve University and was trained in internal medicine and gastroenterology. Subsequently, he was on the faculty at Harvard Medical School and the University of Massachusetts Medical School, where he was Director of Gastroenterology and Associate Dean of Admissions. He then became Dean of the Medical College of Georgia before coming to Upstate Medical University as President in 1993. After Dr. Eastwood left the presidency of Upstate Medical University, he served as Interim President of Case Western Reserve University (CWRU) 2006-07, then directed the Inamori International Center for Ethics and Excellence at CWRU 2007-08. He has authored over 130 articles and book chapters and has written or edited several books.



Robert Gregory, M.D. is Professor and Chair in the Department of Psychiatry at SUNY Upstate Medical University and Chief of Psychiatry at University Hospital in Syracuse, NY. A graduate of Harvard's psychiatry residency training program at Beth Israel Hospital in Boston, Dr. Gregory's clinical and research interests include borderline personality disorder, addictions, suicide prevention, and psychotherapy. He is the founder of dynamic deconstructive psychotherapy (DDP), a weekly individual treatment for borderline personality disorder. DDP combines translational neuroscience with object relations theory and is included on the National Registry of Evidence-Based Programs and Practices. Dr. Gregory has authored numerous theoretical and empirical papers and has presented his work nationally and internationally.



Fred Cohen, L.L.B., L.L.M., Yale Law School, has been a full professor at a number of leading law schools. He is one of the founders of the Graduate School of Criminal Justice, S.U.N.Y. @ Albany and developed the law component, including juvenile justice, of its Ph.D. program. He is now Professor Emeritus. Mr. Cohen served as a court-appointed Monitor for mental health services in Ohio in *Dunn v. Voinovich* and for medical and dental care services in Ohio in *Fussell v. Wilkinson*. He was the court-appointed Independent Fact Finder in *S.H. v. Stickrath*. He is author of *Practical Guide to Correctional Mental Health Care and the Law*, (2011); the leading text in the area. He is also the author of a number of case books, treatises and articles on law and deviance in general. Mr. Cohen is the Executive Editor of *Correctional Mental Health Report*, *Correctional Law Reporter*, and *Correctional Health Care Report*. He served as a Reporter to the ABA, Juvenile Justice Standards Project, served on the ABA Task Force revising Correctional Standards, and gave expert testimony before the ABA, Justice Kennedy Committee and the Commission on Safety and Abuse in America's Prisons. He is also the on the ABA's Subcommittee dealing with Alternative Means for Providing Correctional Oversight.



Robert W. Daly, M.D. is Professor of Psychiatry and of Bioethics and Humanities Emeritus at SUNY Upstate Medical University. He engaged in the practice of psychiatry and of organizational consulting for over forty years. Dr. Daly has also held appointments in the Strategic Air Command (USAF), the Department of the History and Philosophy of Science at Cambridge University (Kings College), and Cornell University. He is co-editor of *The Cultures of Medicine*, Vol. 8 (Johns Hopkins University Press). His articles and reviews have been published in *The Psychoanalytic Review*, *The*

American Journal of Psychiatry, Psychiatry, The International Journal of Psychiatry, Social Science and Medicine, Nutrition, Santa Clara Lawyer, The Syracuse Journal of International Law and Commerce, and recently in the Bulletin of the Association for the Advancement of Philosophy and Psychiatry. Dr. Daly lectures on topics in psychiatry, psychoanalysis, bioethics and philosophy at universities and health care organizations in Europe and China, as well as the United States. His poetry has appeared in *The Healing Muse*.



Mantosh Dewan, MD is SUNY Distinguished Service Professor and former Chair, Department of Psychiatry at Upstate Medical University in Syracuse, New York, where he has also served as Director of Undergraduate Education and Director of Residency Training. His 200 papers, chapters, abstracts and presentations are on topics that range from brain imaging and economics of mental health care to psychotherapy. His work has been funded by grants from the National Institute of Mental Health [NIMH] and Health Resources and Services Administration [HRSA]. He is co-Editor of two books: **The Difficult to Treat Psychiatric Patient** [2001], which has been translated into Italian and Spanish and the best-seller, **The Art and Science of Brief Psychotherapies** [2004], now in its 2nd edition [2012], which has been translated into Italian, Japanese, Taiwanese, Turkish and Chinese and chosen for the Core Competencies in Psychotherapy Series by the American Psychiatric Association's press. He has an active clinical practice and is listed in *The Best Doctors in America*. He is a Distinguished Fellow of the American Psychiatric Association and has received the Scientific Achievement Award from the Indo-American Psychiatrists Association, the Exemplary Psychiatrist Award from National Alliance for the Mentally Ill, the 2010 George Tarjan Award from the American Psychiatric Association, was invited to present the 2nd A P Patkar Oration at TN Medical College in Mumbai in 2010 and designated an "Exemplary Chair" by SUNY in 2011. He has served on the Editorial Board of *Annals of Clinical Psychiatry and Surgical Neurology*.



Dr. Kaplan is now Professor and Chair Emeritus, Department of Psychiatry at SUNY Upstate Medical University. He has served on the faculty for over 53 years in various roles, including Director of residency training, Director of undergraduate education (medical school), Director of the Behavioral Science Program, and Chair of the Department of Psychiatry from 1985 until 1999. For the College of Medicine he has served on and chaired many committees, including the Faculty Appointments and Promotions Committee, which he chaired for over 12 years. He also served on the Part 1 Committee of the American Board of Psychiatry and Neurology for 24 years. Dr. Kaplan is now a Distinguished Life Fellow of the American Psychiatric Association with 50 years of service. Dr. Kaplan has known Dr. Szasz since 1956, first as a medical student, then as a psychiatry resident, and still later as a colleague and close friend.



James L. Knoll, IV, M.D. is the Director of Forensic Psychiatry and Professor of Psychiatry at SUNY Upstate Medical University in Syracuse, NY. Dr. Knoll is board certified in both adult and forensic psychiatry. He has worked as a forensic evaluator for state and federal courts, corrections, and the private sector. He has served as a consulting forensic expert for the DEA, FBI, NASA, DOJ, ACLU, and law enforcement. Dr. Knoll served as the Medical Director of Psychiatric Services for the New Hampshire State Prison system for six years, and has been the training director of the SUNY Upstate forensic psychiatry fellowship training program since 2006. He is Emeritus Editor-in-Chief of the *Psychiatric Times* (www.psychiatristimes.com), one of the most widely read publications in the field of psychiatry. Dr. Knoll has over 130 publications in journals and book chapters. His main areas of research interest include suicide, violence prevention, and psychoanalytic theory.



Ronald W. Pies MD is Professor of Psychiatry, Lecturer on Bioethics & Humanities, SUNY Upstate Medical University and Clinical Professor of Psychiatry, Tufts University School of Medicine. He received his undergraduate degree at Cornell University, and attended medical school and psychiatric residency at Upstate Medical University. He is a professor of psychiatry on the faculties of both Upstate Medical University and Tufts University, and is an Editor-in-Chief Emeritus of *Psychiatric Times*. Dr. Pies's interests extend to philosophy, comparative religious ethics, and literature. He is the author or co-author of several psychiatric textbooks (co-editor, with Mantosh Dewan MD, of *The Difficult-to-Treat Psychiatric Patient*; and author of *Psychiatry on the Edge*, a collection of essays). Dr. Pies has also published poetry, short stories, and, most recently, the novel, *The Director of Minor Tragedies*.
