Nearly \$120,000 in grants supports Upstate's Mission

Nearly \$120,000 was awarded to 59 Upstate projects through the Advocates' 2020-2021 grant-funding program. **A few of the programs receiving support include:**

- Upstate New York Poison Center: a family guide to poison prevention and the distribution of medicine lock boxes to reduce unintentional poisonings;

- Pediatrics: hospital school program resource materials and support of the "Wee Care Through Cancer" and "Patient Experience Awards" programs. Funding will also support the "Creating a welcoming environment for patients at the Child Abuse Referral and Evaluation (CARE) Clinic" program;

- Transitional Care Unit: heart failure pilot project and the “Patients’ Unmet Needs” program;
- Nursing: a Medikin doll to aid in teaching children about procedures before they happen;

- Physical Medicine and Rehabilitation: the Therapeutic Recreation Patient & Family Enrichment” program for the Stroke Support Group;
