Messaging on the Safety Signal for Pfizer's Bivalent COVID-19 Vaccine

Last Friday, the Centers for Disease Control and Prevention (CDC) announced that a [vaccine safety monitoring system](#) called the Vaccine Safety Datalink picked up a “safety signal” possibly linking Pfizer’s COVID-19 bivalent vaccine with an increased risk of stroke in people 65 and older. Since then, federal health officials have thoroughly reviewed the data (from the Datalink system and other safety monitoring systems) and concluded it’s very unlikely that there’s a true clinical risk of stroke associated with Pfizer’s vaccine. But with confusing media coverage and misinformation, questions about vaccine safety continue to circulate.

We’ve updated our [Answers to Tough Questions](#) to help you answer questions about this issue. Here are topline messages from our updated messaging guidance:

- After extensive review of the latest vaccine safety data, federal health officials have said it's very unlikely that there's a true clinical risk of stroke associated with Pfizer's COVID-19 booster.
- The safety system that monitors COVID-19 vaccine safety is the most extensive in U.S. history.
- The COVID-19 vaccines and updated boosters are safe. Getting vaccinated and boosted remains our best defense against serious illness and hospitalization due to COVID-19.

As vaccine misinformation continues to spread, use our [Misinformation Alerts](#) to help combat misinformation. Developed through automated media monitoring and manual review by public health data analysts at the Public Good Projects, the [Misinformation Alerts](#) identify misinformation circulating on social media and in the news (such as false claims about football player [Damar Hamlin's recent cardiac arrest](#)). The alerts are categorized as low, medium, or high risk and offer guidance on how to respond with messaging that’s focused on the facts. CDC Releases Two Respiratory Disease Dashboards

COVID-19, influenza, and respiratory syncytial virus (RSV) can cause severe disease resulting in preventable deaths, thousands to hundreds of thousands of hospitalizations, and millions of illnesses each year in the United States. This combined disease burden can impose a strain on healthcare systems during periods of intense circulation or cocirculation. We know that access to timely data is critical for understanding trends in virus circulation, estimating disease burden, and responding to outbreaks. While CDC tracks COVID-19, flu, and RSV hospitalizations through sentinel surveillance systems, until now, there has not been one place to find integrated data on all three viruses.

The first CDC Dashboard is the [Respiratory Virus Hospitalization Surveillance Network \(RESP-NET\)](#) interactive dashboard comprising data from three networks that conduct population-based surveillance for laboratory-confirmed COVID-19, influenza, and RSV-associated hospitalizations among children and adults. The networks gather data from acute care hospitals in select counties in 13 states covering more than 29 million people and include an estimated 8-10 percent of the U.S. population.

RESP-NET interactive dashboard can be used to follow trends and see comparisons of COVID-19, influenza, and RSV-associated hospitalization rates in different demographic groups including by age, sex, and race and ethnicity, and across seasons. The dashboard is updated weekly.

The second is a [dashboard](#) that provides a view of emergency department visit data for multiple respiratory diseases tracked by the National Syndromic Surveillance Program (NSSP). NSSP is a collaboration between CDC, federal partners, state and local health departments, and academic and private sector partners to collect, analyze, and share electronic data received from multiple health care settings. Data are monitored for a subset of emergency departments across the United States. By tracking symptoms of patients in emergency departments—before a diagnosis is confirmed—public health can detect unusual levels of certain respiratory illnesses, which can serve as an early warning system for troubling increases or outbreaks.

Take 10 and Connect: Taking breaks throughout the day may help relieve stress, ease tensions, or lessen worry. But we often don't take breaks. Even [10 minutes is enough](#) to improve your mental health.

Connecting with others can help us cope with stress and become more resilient. Here are some ways to reduce stress by connecting with others:

- Reach out to your community, family members, or friends. Talk with someone you trust about your feelings or any concerns.
- Make time for cultural, spiritual, or religious activities.
- Volunteer with organizations that interest you. Giving back to others can help you too.
Get outside with others, connect with nature, and explore green spaces.

Prepare for Mental Health: 2022 was full of public health emergencies, including Hurricanes Fiona and Ian; over 1,000 confirmed tornadoes; mpox; and the triple threat of flu, RSV, and COVID-19. Disasters can be stressful and take a toll on mental health. Many of us make resolutions for the New Year, lose weight, work out more, read more, learn a new skill. Why not make one of your resolutions to be ready? Taking steps to prepare for an emergency can help ease your mind and preserve your emotional well-being.

It is natural to feel stress, anxiety, grief, and worry during and after a disaster. Everyone reacts differently, and your own feelings will change over time. Notice and accept how you feel. Taking care of your emotional health during an emergency will help you think clearly and react to the urgent needs to protect yourself and your family. Self-care during an emergency will help your long-term healing. Involve your entire family in planning and practicing how to stay healthy, informed, calm, and connected during an emergency. Create an [Emergency Action Plan](#). Review your plan every six months and update it as necessary; for example, if you move, change jobs, add to your family (i.e., a child or a pet), or experience another significant life event.

How to Help Children Process an Emergency: Regardless of your child's age, he or she may feel upset or have other strong emotions after an emergency. Some children react right away, while others may show signs of difficulty much later. How children react or common signs of distress can vary according to age. Knowing [how to help children cope after an emergency](#) can help them stay healthy in future emergencies.

Setting a good example for your children by managing your stress through healthy lifestyle choices, such as eating healthy, exercising regularly, getting plenty of sleep, and avoiding drugs and alcohol, is critical for parents and caregivers. When you are prepared, rested, and relaxed, you can respond better to unexpected events and can make decisions in the best interest of your family and loved ones.

Many resources are available to help children and their families start a conversation and help navigate through a mental health struggle. CDC's [How Right Now](#) online guide can help kids identify how they're feeling at any given moment and points them to resources for handling emotions like fear, grief, anger, and sadness. It has links to advice, hotlines, and support groups. There's also a section with ideas for practicing gratitude, which is a great way to reduce stress and boost your physical and emotional well-being.

CDC Radiation and Health - RADON

As part of National Radon Action Month, CDC hosted its third Radon Awareness Week from January 23–27. Here is what CDC shared on this year's theme "The 5 Ws of Radon: What's Your Radon Story?"

1. Who is affected by radon?

Anyone can develop lung cancer from long-term exposure to high radon levels.

[Radon](#) is an odorless, invisible radioactive gas released by rocks, soil, and water. It can get into homes or buildings through cracks or holes and build up to higher levels over time. Breathing in high levels of radon can cause lung cancer.

After smoking, radon is the second leading cause of lung cancer. People who smoke and are exposed to harmful levels of radon have a much higher risk of developing lung cancer. However, radon is associated with nearly all lung cancer diagnoses among people who never smoked, like Jackie Nixon. 2. What are the health effects of radon? **Radon can cause lung cancer. The Environmental Protection Agency (EPA) estimates that radon causes 21,000 lung cancer deaths each year.**

Doctors can help prevent lung cancer deaths associated with radon in two ways:

1. Educating and talking about radon with patients
2. Considering the risks of radon when encountering patients with signs of lung cancer who never smoked

The number of Americans who smoke has dropped significantly the last few decades, increasing the proportion of lung cancer deaths associated with radon. Therefore, efforts in lung cancer risk reduction and prevention should address radon. Talk to your doctor if you have concerns about radon exposure. Dr. Timothy Mullet and Lindi Campbell's story is about one doctor's impact in reducing the high rates of lung cancer in Kentucky and how one patient's life was saved by a second opinion that brought her to his clinic.

3. Where can I be exposed to radon? **Radon can build up to harmful levels in any home or building anywhere in the world. People can be exposed to radon in their homes, schools, & workplaces.**

Radon is naturally in all outdoor air, but it is diluted (spread out) to levels that do not put people at risk. Radon can get trapped in any home or building, whether it has a basement or does not, is new or old, or is drafty or sealed. This includes single-family and multi-family homes, apartment buildings, schools, and workplaces anywhere on earth. When radon builds up in the indoor air, people who breathe it in can develop lung cancer over time.

Areas with certain types of rocks or soils naturally have higher levels of radon in the air. CDC's Environmental Public Health Tracking Network works with states to create radon exposure risk maps. Learn how the Tracking program partnered with the Washington Department of Health to create detailed maps of environmental radon levels. See how this motivated one family to make repairs to their home.

4. When should I install a radon reduction system? **First test your home's radon levels. EPA recommends hiring a licensed professional to install a radon reduction system if levels are over 4 pCi/L.**

Homeowners can contact their state radiation control office or purchase a radon test kit at a hardware store. Radon testing is recommended :

- If a home has never been tested
- When buying or selling a home
- After major repairs or renovations
- After installing a radon reduction system

If radon test results are above 4 pCi/L, the Environmental Protection Agency (EPA) recommends contacting a certified radon reduction contractor to install a radon reduction system in your home.

No one wants to put themselves or their loved ones at risk for lung cancer. Yet it's so easy to miss this important opportunity to take preventive action. Many do not know about radon. Those who are informed do not have any type of sign or reminder since radon is invisible and odorless, and lung cancer develops without notice for many years before symptoms show.

For example, Carol was knowledgeable about radon and its risks. When she learned that the radon levels in her home, 10 pCi/L, was equivalent to smoking 20 packs of cigarettes per day or having 500 chest x-rays per year, she sprang into action. 5. **Why** should I raise awareness about radon? **Radon-associated lung cancer can be prevented. Raising awareness about radon risks and how people can protect themselves can save lives.**

Each of the estimated 21,000 lung cancer deaths associated with radon every year could be prevented. Every homeowner, landlord, building manager, and school building manager should test indoor radon levels and install effective radon reduction systems if levels are above 4 pCi/L. Public awareness can save lives from radon, yet still too many people are uninformed. We hope that during this Radon Awareness Week, we have increased public knowledge about radon.

We hope this week

- Motivates people to take protective actions
- Inspires healthcare providers to talk to patients about radon as part of their routine visits.

Researchers have cataloged more than 50 conditions linked to Long COVID that impact nearly every organ system. Estimates vary, but research suggests that between 5 percent and 30 percent of those who had COVID-19 may have Long COVID symptoms.

Combining more than 1,000 hours of interviews, workshops, and human-centered design research with the public, this report puts patients at the center of government innovation.

Guidance to Complete ServNY Notification Drill (LHD BP-4 BPR-4)

Deliverable

The 2022-2023 Public Health emergency Preparedness Program Deliverable BPR-4 requires Local Health Departments (LHD) to use the ServNY Volunteer Management System (VMS) to notify volunteers for a response to a real-world event or as part of a local exercise. This optional course provides further guidance on the completion of this deliverable requirement.

Elements of Completion

1. A minimum of one (1) staff person must complete the drill.
2. Submit ServNY results
3. Provide the date(s) of the drill on the LHD Quarterly Deliverables Report

Frequently Asked Questions

1. Are Counties required to use ServNY?

A: Counties that do not use ServNY to send notification are still encouraged to use ServNY in this deliverable. Some exceptions may be granted on a case-by-case basis for Counties that cannot complete this drill using ServNY. Requests for an exception must be submitted in writing to the appropriate Public Health Regional Representative and the NYSDOH Volunteer Coordinator and approved prior to completing the drill.

2. Does a notification have to be sent specifically for this drill?

A: Any notification sent during the current Budget Period can be used to satisfy the elements of completion of this deliverable.

3. Does a certain number of volunteers need to be notified?

A: No, BPR-4 does not specify a certain number of volunteers that need to be sent a notification.

4. Do the volunteers need to acknowledge receipt of the notification?

A: No, BPR-4 does not require a certain number of acknowledgements. However, it is a good idea to track acknowledgments and reach out to volunteers that have not acknowledged receipt of a notification as a means to remain engaged with our volunteers and to confirm that contact information used by ServNY is still valid.
