### **EMTALA Mandatory Education**

Applies to All Physicians

EMTALA Alert You should have received over the past couple of days a request for mandatory education with regard to EMTALA regulations. Thought I would provide a brief background as to why this was deemed necessary at this time.

This hospital accepts thousands of patients annually in transfer from other hospitals in our region. The vast majority of these patients are taken in and provided care and this is a point of pride for our organization. In fact, Upstate ranks at the 90<sup>th</sup> percentile of academic medical centers for transfers in from other hospitals. However, on occasion patients are denied access to our hospital by a physician who is on call. In these cases, when a decision is needed to deny transfer when capacity is available, there needs to be very clear documentation as to the rational as to why we cannot provide the services these patients need.

Our hospital has been recently reviewed with regard to three of these cases and while we are still waiting any regulatory findings related to these cases we felt it critical to provide provider education on these regulations for all members of the medical staff.

Please take a few minutes to review and attest to the education sent via email. As a reminder this education must be completed by January 31, 2017. Non compliance of this mandatory education will put your membership on the Upstate Medical Staff in jeopardy.


