Upcoming Restrictions to Lab Ordering in the Hospital

Applies All Physicians

Correct laboratory testing is a critical tool in patient management. The Laboratory Formulary Committee was formed in 2016 to optimize usage of this tool to best help patient care without excessive cost or mismanagement due to incorrect ordering. One of the approaches the committee has worked on is the creation of a new policy OMS L-04 (Tiered Categorization of Laboratory Testing) which defines the categorization of laboratory tests according to a Tiered system. The intent of this categorization is to require the input of more senior or specialized clinicians when ordering laboratory tests which:

- 1) are not needed in an emergency,
- 2) have a higher potential for misinterpretation,
- 3) require higher usage of resources, or
- 4) should only be ordered after additional consultation.

At this time, the Tier Categorization will only be rolled out for inpatient and Emergency Room ordering at both campuses. A similar ordering system will be rolled out for outpatient ordering in the future.

The following are the defined tiers:

Tier 1:

All credentialed medical providers and post-graduate trainees are able to order these tests. There are roughly 550 tests in Tier 1.

Tier 2:

Orders for these tests may be placed by providers listed above in Tier 1, but if ordered by a post-graduate trainee, will require a medical staff member's second signature within Epic before the test order will be processed. Orders in Epic will provide notification of this requirement. Tier 2 includes approximately 300 tests.

Tier 3:

Tests in this tier may be placed by an appropriately authorized provider (the Tier 3 provider list is maintained by the Laboratory Formulary Committee). Non-Tier 3 providers will get a message when attempting to order a Tier 3 test, telling them to call the lab for a list of Tier 3 providers to contact. Tier 3 currently includes 19 tests.

Tier 4:

Tests that are "off formulary"; these are not orderable through Epic from the Upstate laboratory system. Orders for these tests require pre-authorization through the Laboratory Formulary Committee using form F95098.

Forms to request a change in tier (**F95100**), request access as a Tier 3 provider (**F95099**), or request an off formulary test (**F95098**) are available.

Ordering providers will start seeing Tier assignments on Epic orders starting around 12/1/2017, with implementation of the restrictions described above slated for 1/1/2018.
