Eliminating Contact Precautions for MRSA and VRE

Applies to Community Campus Physicians

MRSA & VRE Informational

- Starting June 1, patients at the Community campus with MRSA and/or VRE will no longer be on Contact Precautions (unless there are uncontained secretions, excretions or drainage).
- ➤ This is a 6-month pilot program at the Community campus only.
 - Decision based on Community Campus Risk Assessment data from 2015.
 - The MRSA and VRE onset rate at the Community Campus is < 1%. This low rate has been sustained over several years.
 - Hand Hygiene compliance at the Community Campus is 97%. High compliance rate sustained over several years.

> During the 6-month pilot:

- o Policies will not change
- EPIC "Infection Control Alerts" will still display in the header but there is no need to act on them if they are for MRSA and/or VRE
- o The screening protocols will remain the same
 - CM M-25: MRSA and VRE Patient Screening and Management
- Patients with MRSA or VRE will **not** need to be in private rooms
