#### **Medical Abbreviations**

Applies to All Physicians

Abbreviations Informational While the use of abbreviations for clinical documentation allows for improved efficiency, it is important to remember that not all providers are familiar with your individualized medical shorthand. There may be patient safety issues if the abbreviations are not approved and the abbreviations create confusion to providers in different areas. ### **ICD-10** Documentation Requirements

Applies to All Physicians

Doc Requirements Informational One of the key findings we are already seeing in the records is a need for greater specificity; more adjectives as Dr. Glidden puts it. Here are a few examples of what we need you to document...:

- Laterality: Right, Left, Bilateral (e.g. Left sided Pulmonary embolism)
- Encounter Type: Initial, subsequent, sequela
  - initial encounters are used while the patient is receiving active treatment for the injury S
  - Subsequent encounters are used for encounters after the patient has received active treatment of the injury and is receiving routine care for the injury during the healing or recovery phase
  - Sequela encounters are used for complications or conditions that arise as a direct result of an injury
- Stage of Disease: Acute, Chronic, acute on chronic
- Anatomy: Describe location as specifically as possible
- Manifestations (associated/related conditions): Must document and link comorbid manifestations related to an overriding condition. Use combination codes when available.
  - o Diabetes with ESRD
  - o Coagulopathy secondary to Cirrhosis, sepsis, etc.
  - Acute blood loss anemia secondary to variceal bleed secondary to cirrhosis

ALERT-Highest priority emergency communication; warrants immediate action or attention by the recipient.

HIGH ADVISORY-High priority does not warrant immediate action but recipients should be aware.

ADVISORY-Provides very important information for a specific incident or situation that does not require immediate action.

UPDATES TO ALERTS AND ADVISORIES. Provides updated information regarding an incident or situation; unlikely to require immediate action.

- Avoid non-specific or general diagnoses that encompass multiple related problems
  - o UTI should be cystitis, pyelonephritis, urethritis, etc.
  - Hip fracture should be intertrochanteric femur fracture, sub-capital femur fracture, etc.
- Causation/Etiology: Type of Infectious agent, trauma, environmental factor(smoking, drugs, etc)
- Under-dosing: Intentional, unintentional
- **Healing Level:** Routine, delayed, non-union, Etc.
- Remember that hospital documentation can include possible, probable, likely or suspected.
