The POISON CENTER CELEBRATES 65 YEARS!!!

The Upstate New York Poison Center operates as a model of excellence as a state-designated regional poison center under the NYS Department of Health. Since our start up in 1957 as the Central New York Poison Center, we expanded from a 14-county service area to now serve 54 of the 62 counties of NYS. In 2006, we announced a name change, becoming the Upstate New York Poison Center, to better align with the geographic location of our new service area and the name of our host institution, Upstate Medical University.

We assist both the medical community and the public with poison emergencies by providing state-of-the-art management expertise with a goal of reducing the number, the cost, and the severity of poisonings in NYS. Poison center staff provides telephone management for poisonings 24/7 to 54 counties, 125 hospitals and to a population base of 7.3 million people. The clinical and education staff are committed to positioning the Poison Center as **The Call to Make For All Things Poison.**

Our staff has grown over the years to accommodate the population we serve with 21 clinical and medical toxicologists and 21 specialists in poison information (SPIs). Our public education team now consists of three full-time educators and a dedicated marketing coordinator.

Each year our center manages close to 50,000 calls from healthcare providers, 911 operators, hospitals, industry, schools, and the public.

Vision

The demand for the services of the Upstate New York Poison Center grows, especially as new drugs and other potential poisons are

- With 90% of calls about children aged 5 and under managed at home
- 65% of our calls were unintentional

introduced to our communities.

While still in the throes of a pandemic, when most face-toface outreach was at a standstill, our poison center continued to expand outreach using several strategies: Instagram, to engage a new audience: educational videos posted on-line to create awareness; news releases on current topics such as the dangers of hand sanitizers during Covid and also on marijuana edibles to keep our population informed. Additionally, we expanded our webinar offerings, based on the identified needs of our population served, and provided new educational and marketing tactics geared to expand our online audience.

Strategy

Throughout the year of celebration and beyond, the UNYPC staff will continue to position the poison center as "THE CALL TO MAKE FOR ALL THINGS POISON". Our goal is to continue to achieve recognition as a valued and an essential service for both poison emergencies and poison information throughout our service area.

As the distribution of athome Covid-19 test kits rolls out through local school districts, community distribution sites and even through the United States Postal Service, the poison center suggests these new kits be used safely.

There are a number of different at-home Covid-19 test kits available. Each kit contains potentially dangerous compounds in the small liquid bottles found in each kit. That liquid creates the chemical reaction necessary to produce a positive or negative result. Fortunately, as each test kit contains only a small amount of these toxic chemicals, most people would not become severely ill from a single accidental exposure.

However, to a young child, a small bottle can look like a treasure, which could lead to an ingestion. Dr. Vince Calleo, UNYPC medical director cautions that each case is unique and recommends a call to the poison center with any questions. If symptoms develop, he points out that it is important to call the poison center or seek immediate medical attention.

To date, the Upstate New York Poison Center has received more than a dozen calls in regard to these products.

Remember, the Upstate New York Poison Center is the call to make for all things poison. In case of a poisoning or for information, call our free service at 1-800-222-1222.

Steps to take to avoid a poisoning:

- Promptly remove the Covid-19 test kit from your child's backpack.
- Store the kit, like all medications and household chemicals, up and out of sight and reach of children.
- Read kit instructions and follow directions to ensure accurate test results.
- When finished using the kit, immediately place in the trash.

Tetrahydrocannabinol (THC) in Edibles

The Centers for Disease Control (CDC) estimates that 48.2 million people in the US used cannabis in 2019¹. Cannabidiol (CBD) and THC are two main compounds in cannabis. THC affects the way the brain works and produces a "high" sensation. It can enter the body by smoking cannabis but it is also found in oils, edibles, tinctures, capsules. Edibles with THC can be much more dangerous for children, who might eat them accidentally.



Remember to keep these products out of reach and out of sight of children. Keeping them in medication lock boxes may help prevent unintentional exposures.



The Upstate New York Poison Center wants you to know:

- It may take longer to feel the effects of the edible form of THC products than from smoking THC. In fact, effects may be delayed up to a few hours after ingestion.
- The effects from edible THC may last longer than the effects from smoking THC.
- Some forms of edible THC can be easily confused with regular foods, like gummies or brownies.
- Some states saw increases in pediatric exposures to THC products after THC was legalized.
- Children may experience more severe effects after ingesting an edible THC product.
- Children exposed to edible THC can develop concerning symptoms. Symptoms can include changes in heart rate, difficulty breathing, vomiting, change in mental status, and even seizures.

SNADD offers a solution for the safe disposal of household medications in Onondaga County. As a collaborative effort, local police departments act as collection sites for both over-the-counter and prescription medications. The program helps to reduce the availability of all drugs in the home reducing the risk of someone taking a medicine by mistake or someone taking a medication for their use.
