Greetings! I write this as we just wrapped up our Middle States Accreditation, with extremely positive results and feedback from the site visitors. I want to thank Dr. Lynn Cleary, the lead for the Middle States Accreditation, as well as the entire

Accreditation office, the offices of Student affairs, Assessment, Evaluation, and Research, and faculty, staff, and students who participated in this. One down, one more accreditation to go!

For those who are not familiar, Middle States was here to accredit Upstate as an entire Institution (all 4 colleges-College of Medicine, College of Nursing, College of Nursing, and College of Graduate Studies), and is the body that accredits all public and privates schools in the mid-Atlantic region (MSCHE focused on higher education). Through this rigorous process, we came together as an institution to demonstrate all aspects of how a higher education institution functions.

Similarly, the LCME (Liaison Committee on Medical Education) accredits all US and Canadian Allopathic medical schools in the country. The LCME will focus

specifically on all aspects of the College of Medicine and its functions. But there are many similarities with the two

Accreditation Self-Study Process Updates

Liaison Committee on Higher Education (LCME)	Middle States Commission on Higher Education
The College of Medicine continues to work on the LCME Data Collection Instrument (DCI) in preparation for our December 21 deadline for submission to the LCME. The DCI contains 12 standards with 93 elements focusing on mission, leadership, finances and resources, faculty, students, educational resources, diversity, curriculum content and management, assessment, learning environment, opportunities for scholarship and service learning, committee structures, bylaws, policies and procedures. At the closing presentation, Jay Perman, MD, President of the University of Maryland, Baltimore, and chair of the Site Visit Team found Upstate to be in full compliance with all standards. He highlighted the strategic plan process, efforts to recruit Native-American students, the infrastructure to support student success, and the resilience and commitment to the university during leadership transition. The team's findings will be submitted to the Commission who will ultimately make a decision about compliance in spring 2019. The Site Visit Team had no recommendations which would require follow-up reports. The anticipated year of the next institutional accreditation survey visit will be in 2026. Thank you to everyone who worked on the self-study and contributed to the success of this site visit!

AAMC Graduation Questionnaire (GQ), Year Two Survey (Y2Q) & Mistreatment

For 5 years in a row, 100% of our graduation students indicated on the GQ that they are aware that Upstate has a Mistreatment Policy, and for the class of 2017, 97% in Syracuse and 94% in Binghamton know the procedures for reporting mistreatment! Our 2017 Y2Q results of our 2nd year medical students were also encouraging with 100% of our students aware of Upstate's Mistreatment Policy and 98% aware of mechanism for reporting mistreatment. Finally, the February 2018 Independent Student Analysis report indicated, *Students are overall satisfied with the learning environment and opportunities available through SUNY Upstate, with many criteria rated above 90% satisfied. Students are very satisfied with adequacy of the medical school's student mistreatment policy (95%), adequacy of the mechanisms to report mistreatment (96%), and adequacy of medical school activities to prevent mistreatment (92%).*

The Mistreatment QR code is in every syllabus, and the link is on the cards handed out at all orientations. You can always type "mistreatment" in the search bar of the Upstate website to give you the link for the policy and procedures.

From The Office of Evaluation, Assessment and Research

The Office of Evaluation, Assessment and Research has completed our work on the Middle States accreditation process which has re-affirmed the importance of Upstate's systematic and organized approach to student assessment and curricular evaluation. We look forward to working with all of the colleges to continue enhancing our programs.

Here are a few things from the Middle States process that might be useful to all students, staff and faculty:

Did you know that Upstate has institutional student learning outcomes that bridge all of our programs and Upstate's mission? These outcomes can be found here: <u>http://www.upstate.edu/student-handbook/institutional-outcomes.php</u>

Did you know that Dr. Poole is part of an institutional-level committee, the Student Learning Outcomes Committee (SLOC), that reviews the state of learning assessment at Upstate? He is the MD program's representative and, along with colleagues from all 4 colleges, the Registrar, and our office, we have designed tools to enhance curricular design and learning assessment. This includes curricular maps which link every required course to the Graduation Competencies and the Institutional Student Leaning Outcomes. SLOC has also built assessment portfolios which outline how assessment decisions are made and provide evidence that assessment strategies enhance our programs. All of these documents for all Upstate degree programs are available to all faculty and, upon request, interested staff, on Blackboard in a course called CUR 101.

Focusing back on the MD program, we are working on educational innovation scholarship with Drs. Caruso-Brown, Hobart, and Stewart as well as 2 projects with medical students. The AAMC submission deadline is coming up fast so we will be finishing up and submitting proposals. We are also excited to be part of both of the Dean's innovation task forces to represent assessment strategy.

Finally, and perhaps of most interest to students and faculty in the MD program, we continue quality improvement efforts at the course and clerkship levels. We are working with clerkship directors to identify patterns in scoring among the SPEs and continue to monitor clerkship clinical evaluation data as they come in.

What's New in Phase 2
